The 2012 Election Day is approaching quickly; the last day to register to vote was October 22nd!. Remember the date: November 6th is ELECTION DAY! For the first time ever, Voting Registration could have been done online, making it easier and faster than ever. Our office and other organizations have spent long hours trying to register Cal students to vote.

public education system. One of the most important prop is Prop 30, which aims to increase income tax for the top 2% and sales tax by 1/4 of a cent. If this prop fails, public institutions, namely Cal, will suffer a \$375.4 million trigger cut, raising our tuition by 20.3%.

Another important prop is Prop 32: Special Exemption Act, which will ban corporate and union contribution to state and local candidates. This prop will
